

## Terms and Conditions

Please ensure that you read carefully the Terms and Conditions, which you have to comply with in order to trade in Carnaval Del Pueblo (CdP). Signing below constitutes an agreement to comply with the following rules and regulations and those usual to such an event.

1. A food Hygiene Certificate is compulsory for food stall holders, a failure to meet this requirement will result in the cancellation of the stall and the no return of the money already paid.
2. Every stall holder will be provided with a metal table **of 2 metres wide by 1 meter deep**. You may use up to **3 meters of space at the back** of this structure. This table will be covered by a roof of the same dimensions. If you are bringing your own structure it should not exceed any more space than the measurements mentioned above.  
  
If you would like to discuss the possibility of occupying a different sized space or erecting/parking a different sized structure, please call Jana on 0207 686 1633, as soon as possible and we will do our best to accommodate your needs. **This will not be possible on the day of the event as the complexities of 'housing' everybody within the time allocated is very difficult.** It is therefore, imperative to have any changes authorised in writing by Jana in advance or stewards will prevent you setting up shop
3. If you are reserving a space for a Catering Van – You need to write the **exact dimensions** of the vehicle (length and width) on the reservation slip. The measurements stated here can not be exceeded on the event day otherwise you will be prevented for trading.
4. Every stall holder or Catering van/Caravan trader must comply with the health and safety regulations. Please remember that Carnaval del Pueblo has the full right to close down any traders who do not follow these rules and regulations. (A copy of these regulations will be sent to you when you reserve your stall)
5. It is the responsibility of the stall holders to bring their own source of energy, **which must be working with DIESEL. Kerosene generators are not permitted at any time.** The generator needs to be properly isolated and kept away from the reach of the public. All food stalls and catering vehicles must have a fire extinguisher. Please note that you will be held responsible for any accident that your negligence may cause.
6. **The sale of alcoholic beverages is completely forbidden.** This clause is in accordance with Southwark Council legislation for their events. **Any stall that is found selling any type of alcoholic beverage will immediately be closed down.** Please note that you may be liable to have criminal charges brought against you, by Southwark council and the Organizers of the event, if found to be violating this clause.
7. For security reasons there are no vehicles allowed behind the stalls, besides you have a special permission from CdP. Everybody has to move his car to the signed parking spaces latest at 10.00 AM on the day of the event. **Persons who leave their car behind the stalls during the event would have to pay a fine of £100.**
8. **Failure to meet any of the terms and conditions stated in this document will result in having your stall closed down. You will also lose any right of getting a refund.**

### **Disclaimer:**

CdP shall not be held responsible for any acts of God that delay or prevent the event such as flooding, earthquakes or any other adverse weather conditions - as well as any kind of political changes or influences.

CdP cannot provide the refunding of already paid money, if any circumstances make the event not to be held.
